Due to the lack of festivals, teams can arrange games in November as long as permission is requested beforehand. Try to arrange to play games that have been cancelled throughout the season.

# **Discipline:**

We have one case outstanding. There is still a lot of disturbing behaviour going on each Sunday on the touchlines. You need to talk about it in your clubs and everybody has a duty to challenge bad behaviour. We have had 6/7 reports since last month's meeting. It's not good enough. As clubs you have to work together to sort out troublesome parents. People are still putting stuff on social media (Facebook). Once in the public domain it is very difficult to remove negative comments and people will take offense. The RFL Safeguarding team are dealing with some issues now. People are bringing the leagues, the clubs and the game into disrepute and they need to stop. Make sure your club informs parents are what is and is not acceptable before you find yourselves in hot water.

We are a development league. There is no place for win-at-all-cost coaching when developing young players. If that is how you want to coach you are in the wrong age group – move to 13-15s where results do matter.

Have you seen the Tony Carroll video? They are having the same issues in Australia and this video is everything not needed in the game. He has received a coaching ban – do we have to start doing the same?

#### **Team Sheets:**

The team sheet is a legal document and is needed in case of an insurance claim yet we are still getting them in with important details missing.

- Make sure you state who is playing in the boxes marked Home and Away
- Complete the pre-match checks
- Make sure the coaches sign

Not completing a team sheet properly is negligence and could be used against you in an insurance case.

### **Registrations:**

We are all encouraged to protect our personal details due to identity theft. Would you leave your passport/ bank details lying around for anyone to look at? This year we have had 5 cases of teams losing their whole set of cards. These cards have a child's photo, date of birth, name and the place they can be found on them and yet are getting mislaid. It is your responsibility to protect the children's identity as well as you would protect your own. This is a safeguarding issue – keep hold of your cards!

When registering a player you have to provide proof of ID. There is no point in sending me a registration in one name and ID in another – what does that prove? You have the right to be called whatever you want (within reason!) but your legal name is the one on your birth certificate. If you want to be known by a different name you can, but for legal reasons you have to prove that you are known by that name. For registration purposes, if the registration is to be in a different name than that on the birth certificate it MUST be accompanied by either a copy of a Change of Name Deed or an official letter (from school/ doctor on headed paper) stating that Joe Bloggs is known as Joe Smith.
